### Office of Management and Budget Memo-25-13

- Office of Management and Budget issued a memo (M-25-13) ordering a temporary pause to all federal grants, loans and other financial assistance programs.
- The temporary pause is to provide the administration time to review agencies and determine best use of those funds with the President's priorities:
  - Protecting the American People Against Invasion
  - Reevaluating and Realigning United States Foreign Aid
  - Putting America First in International Environmental Agreements
  - Unleashing American Energy
  - Ending Radical and Wasteful Government DEI Programs and Preferencing
  - Defending Women from Gender Ideology Extremism and Restoring Biological Truth to the Federal Government
  - Enforcing the Hyde Amendment



### New York et al. v. Trump, No. 25-cv-39-JJM-PAS (D.R.I.), ECF No. 50 (Jan. 31, 2025)

- Federal agencies cannot pause, freeze, impede, block, cancel, or terminate any awards or obligations on the basis of the OMB Memo, or on the basis of the President's recently issued Executive Orders.
- This prohibition applies to all awards or obligations—not just those involving the Plaintiff States in the above-referenced case—and also applies to future assistance (not just current or existing awards or obligations).
- Agencies may exercise their own authority to pause awards or obligations, provided agencies do so purely based on their own discretion—not as a result of the OMB Memo or the President's Executive Orders—and provided the pause complies with all notice and procedural requirements in the award, agreement, or other instrument relating to such a pause.

## Scope Modification in Response to Shifting Funding Landscape

Federal funders are considering shifts based on multiple Executive Orders (EOs) issued in January 2025. As part of those shifts, PIs may need to modify the scope and/or budget for ongoing and newly funded projects. Understandably, PIs are concerned about possible modifications and how it might impact the trajectory of their research.

If a PI is asked to modify their project scope, here are four things to consider:

- 1. How can the project be modified to fit with the **portfolio of the funder**?
- 2. Can the modification focus on accelerating the research?
- 3. Is there an opportunity to align with **emerging technology**?
- 4. Are there opportunities to **enhance the evidence-base**?

The modification of a project hinges greatly on the funder, mechanism, and shifting priorities. There is no approach that will work for all grants, and the value and success of modification hinges significantly on careful execution.



### **Funding Support During this Transition**

• Is there a consensus/university approved response or should it be PI determined?

- Can you elaborate more on **budget balances** and how PIs should proceed with the possibility of the following year's budget not being renewed? Can you also talk to how to proceed with communication with subrecipients?
- There are lots of questions about funding:
  - How will loss of faculty FTE from suspended/pulled grants be handled?
  - How will this affect staff in research support positions? Will there be personnel layoffs?
  - What does this mean for our current graduate students and their funding support?
  - Will wages be affected?



#### **University Response**

- Can you plan a **weekly meeting** with managers updates, and they can disseminate info to their departments?
- Given how central the research mission is to our university, why is there not a stronger, more visible response to the current administration's actions, which create uncertainty about the future of grant funding? Could we take a **proactive role** by organizing a March for Science in Salt Lake City, inviting peer institutions to join us in voicing our concerns and advocating for the vital importance of research and science?
- Regarding future grant submissions, are there existing opportunities that are more or less likely to be affected?
  - Health Disparities/Health Equity



#### **Additional Questions**

- Any additional **guidance on travel** is very welcome. Fielding lots of questions from trainees, scholars, and other grant recipients. Since NIH POs can't talk, we can't consult with them for guidance.
- Will the University continue to support **bridge funding** recognizing that federal funding will be unstable/difficult to obtain with this current administration?
- If my parent grant is not related to any DEI activities but I do have a **diversity supplement** supporting a PhD student, would there be a chance that both my parent award and diversity supplement could be cancelled?
- What is the future of Early Investigator/training funding?
